- All PO's for the five tubs sold must be received by January 31st, 2010 to be eligible. Please note that WETSTYLE will not be awarding a bonus for 1 tub, 2 tubs, 3 tubs or 4 tubs. 5 Tubs must be sold between September 1st, 2009 and January 31st, 2010 to claim the bonus.
- This program does not apply to project sales (multi unit residences or quotation based sales), products on which WETSTYLE has extended an additional discount, showroom orders or orders for personal use.
- No item can be accounted for more than once.
- Cash amounts are not transferable and will be given to the participating sales person only.
- All forms should be received by February 28, 2010.
- This promotion may be cancelled at any time without notice.

- Each time you sell a bathtub, you must fill out the attached form. Make sure to keep a copy of each form for your records. You must then send us the completed form by way of fax (1 450-536-0202) or email at [service@wetstyle.ca](mailto:service@wetstyle.ca), so we can track the sale to you.
- You must fax us a copy of the customer's invoice along with each form.
- The checks will be issued in February 2010.
- Each sales person is responsible for payment of all applicable taxes on the bonus.
- WETSTYLE is required by law to report certain payments made to vendors. In order to comply with Federal Law, we are requesting that you provide us with Social Security # and Birth Date. Failure to provide us this information may subject you to backup with holding on all payments we make to you.
